### CATEGORY

#### Award for Wellbeing and Workforce Environment

#### Entry Criteria

  - Candidates should be nominated by their Worksite supervisor, or work colleague.
  - Please ensure all nominees are aware of the nomination submission.
- Judging Criteria
  - Examples of how the individual(s) team has improved Wellbeing and Workforce Environment at the worksite or within the employing company must be provided.
  - Specific examples of how this has positively influenced the wellbeing and workforce environment should also be provided.
